

1946 Accident Case Tried Today

District court today hears further testimony on an automobile accident suit involving a Watkins minor and a former Teachers college student which dates back to July 19, 1946.

On that date, according to the attorneys for the plaintiff, a car driven by Henry Hambrecht, then a student at the Teachers college struck Louis Henry Wittrock Jr., then an infant, on Eighth street south in St. Cloud. Wittrock, now eight years old, has sustained "permanent injuries to his right hand," according to the complaint.

Also named as plaintiff is Wittrock's father, Dr. L. H. Wittrock of Watkins. Young Wittrock is asking for \$15,000 in damages and his father for \$6000 additional damages.

The defendant Hambrecht, now a teacher in Virginia, "specifically denies that he was in any way wilfully or recklessly negligent," according to his legal reply.

A previously tried auto accident suit was cleared up by The Times in a research-check with court authorities. A report in The Times on December 10 stated that a suit brought by Erick Schuenemann against Norbert Rosen and Clarence Groth was settled for an undisclosed amount. No mention was made of a second lawsuit which was brought against Rosen by Groth. In this matter, Groth received a cash settlement award against Rosen also.
